The undersigned corporation, for the purpose of amending its Articles of Incorporation and pursuant to the provisions of the "GENERAL NOT FOR PROFIT CORPORATION LAW" of the State of Missouri, hereby executes the following Articles of Amendment:

1. The name of the corporation is Eastern Jackson County Bar Association, Inc. and it was formerly known as the Independence Bar Association, Inc.

2. There are ninety-one members, having voting rights with respect to amendments.

3. At a meeting of the members, at which a quorum was present, held on May 22, 1969, the membership unanimously voted in favor of amending Paragraph No. 1 of its Articles of Incorporation which states as follows:

"1. The name of the corporation is Independence Bar Association, Inc."


Which now reads:

"1. The name of the corporation is the Eastern Jackson County Bar Association, Inc."

4. This amendment was adopted in the manner prescribed by the "GENERAL NOT FOR PROFIT CORPORATION LAW" of the State of Missouri.
