GENERAL NOT FOR PROFIT CORPORATION ACT

To The Secretary of State,
Jefferson City, Missouri:

We, the undersigned,

being actual persons of the age of twenty-one years or more and citizens of the United States, for the purpose of forming a corporation under the "General Not for Profit Corporation Act" of the State of Missouri, do hereby adopt the following Articles of Incorporation:

1. The name of the corporation is Independence Bar Association, Inc.
2. The period of duration of the corporation is perpetual.
3. The address of the initial Registered Office in the State of Missouri is 208 First National Bank Building, Independence, County of Jackson and the name of its initial registered agent is Jeannette K. Paxton.
4. The first Board of Directors shall be 4 in number, their names and addresses being as follows:

The purpose or purposes for which the corporation is organized are to promote legal science, the efficient administration of justice, to maintain the highest standards of integrity, honor and courtesy in the legal profession; to exert an influence for community improvement and to cultivate fraternity among its members.

6. The members of the corporation may repeal or amend the by-laws of this corporation and may adopt new or additional by-laws.

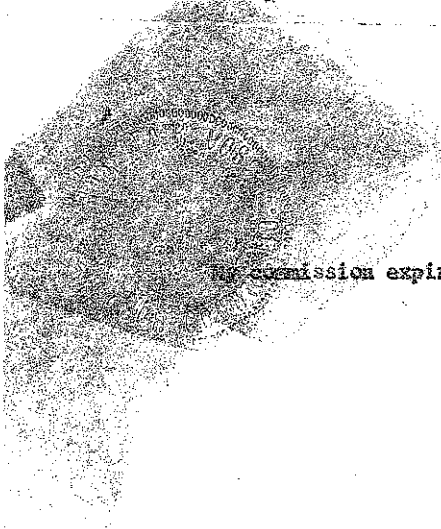
