

KANSAS CITY CHAPTER 13 DOCKETS

On November 17, 2008, the Western District of Missouri Bankruptcy Court will continue with the new procedure for Kansas City chapter 13 dockets. The purpose of the new procedure is to remove cases with an agreed continuance or settlement from the court docket BEFORE the judge takes the bench.

Matters have been scheduled for hearing at 9 AM and at 1:30 PM. Check your hearing notice for the time.

Staff from the court and the chapter 13 trustees office will be available 30 minutes before the start of the docket. You can report last-minute agreed settlements or court filings to court staff and the matter may be removed from the court docket. You will also have an opportunity to discuss a settlement or continuance with opposing counsel and/or with the chapter 13 trustee.

Promptly at 9 AM and 1:30 PM, the courtroom deputy will call the docket in case number order. When the case is called by the courtroom deputy,

counsel for both movant and respondent must be present to communicate with the clerk about the status of the matter on the docket. To expedite this process, speak clearly from your location in the courtroom. There is no need to move to the podium. If your matter is not settled, be prepared to inform the courtroom deputy of the status of the matter including when you contacted opposing counsel or the chapter 13 trustee, and whether you have provided or filed required information. As you are waiting for your case to be called, you may continue to quietly

You must appear when your case is called. Failure to appear may result in entry of an order denying relief if movant fails to appear, or granting relief if respondent fails to appear.

discuss settlements/continuances with opposing counsel and/or the chapter 13 trustee.

After the courtroom deputy has called all cases once, you will have an opportunity to announce any agreed continuances or settlements reached since your case was initially called.

The courtroom deputy will produce a revised docket, removing cases that have been settled, continued or where parties failed to appear. The judge will take the bench to hear all remaining matters.

As always, you are encouraged to pursue settlements and resolve issues with opposing counsel or the chapter 13 trustee prior to the day of court thereby avoiding a court appearance altogether. This procedure will give parties one more opportunity to settle prior to hearing. If you have any questions, please contact Kristina Richardson at kc13orders@mow.uscourts.gov.

COMMISSION ON JUDICIAL SALARIES

The Commission on Judicial Salaries will be meeting to make a recommendation on judicial salaries.

The chair of the commission is Tim Huffier, who is the CEO of Centres in Fenton, MO. The Commission has 10 members, including retired judge Holstein from Springfield. The governor never appointed his 12 members, but the Commission will move forward nevertheless.

- Springfield, November 18, 7:00 p.m.
- St. Louis, November 24, 5:00 p.m.
- Jefferson City, November 25, 9:00 a.m.


FEDERAL COURTS ADVOCATES SECTION
